

GENERAL TERMS & CONDITIONS

1. These rules and regulations shall remain inseparable of the agreement signed between the Exhibition organizers and exhibitors.
2. Any instructions or rules issued by the organizers before or during the Exhibition shall be regarded as complementary of the contract and shall not replace the rules and regulations or the contract's articles.
3. Applying for a space shall be considered as consent of the applicant to pay relevant fees and charges. After accepting participation, each party (the organizer and the exhibitor) become part of a binding contractual agreement.
4. Exhibitors have no right to ask for any service or facility prior to paying full fees.
5. Contract shall be signed by exhibitor or his representative. After getting the contract and paying the down payment agreed upon, organizers will confirm the booking within.
6. Paying the 'Stand' charges (furnished or not, internal or external) is as follows: 100% at signing the contract or submitting to organizers.
7. Organizing company shall secure any additional services asked for by the exhibitor provided that the exhibitor paid for these services.
8. In case, after signing the contract, the exhibitor was unable to use the 'Stand' for reasons belong to him, and he was not waived in writing of the obligation stated in the contract, he shall pay all charges of the 'Stand' plus any other damages that may incur organizers due to this cancellation. Organizing company has the right to ask for any amount to cover the damages been made due to the cancellation of contract by exhibitor?
9. Organizers are in no way responsible for the inability of the exhibitor of placing, loading or arranging the products, or inability to finish the works in the 'Stand' for any other reason.
10. Exhibitor is prohibited from leasing or relinquishing the exhibiting space for a third party. If the exhibit is an agent of a company he shall notify the organizing company at the contract signing procedures. It is allowed that the exhibit display products for which he is the agent or distributor and

in this case, exhibitor shall notify organizer in writing about this.

11. Organizers have the right to change the location and date of exhibition if this serves the interest of the Exhibition. The contract is an agreement by the exhibiting company to take part in the Exhibition organized by the organizing company.
12. Organizers reserve the right to reject an application without stating the reasons. In this case all fees collected from applicant shall be returned to him/them.
13. All other services requested by exhibitors and not covered by the contract shall be charged.
14. Exhibitor shall occupy his 'Stand' or furnish it at least before (1 day) of the official opening of the Exhibition.
15. Organizers shall not be hold responsible for any damage due to the postponement or cancellation of the Exhibition. Organizers thus advice exhibitors to make necessary insurance for that.
16. The responsibility of the organizing company is limited to the free page of the "Exhibition Directory" in case all relevant information of the exhibiting company was delivered at least one month before the inauguration of the Exhibition. Organizers are not responsible of any errors or shortage in the provided information.
17. Exhibitors hereby acknowledge participating in this Exhibition on their own free will and decision.
18. Any dispute between parties regarding the execution or interpretation of the articles of this contract, the dispute shall be settled by Saudi courts within the law of the Kingdom of Saudi Arabia.
19. The Exhibitor will be liable for all, or part of the cost stated in the Application in accordance with the following scale:

Cancellation, 90 days prior to the exhibitions opening date. 50% OF TOTAL COST.

Cancellation, 30 days prior to the exhibitions opening date. 70% OF TOTAL COST.

Cancellation, within the last 30 days prior to the exhibitions opening date. 100% OF TOTAL COST.
